



## HEMODIALYSIS TECHNICIAN TRAINING PROGRAM INFORMATION

### ABOUT US

### PROGRAM OBJECTIVES

Upon successful completion of this program the student should be able to:

1. Correlate normal renal physiology with the path physiology of acute and chronic renal failure.
2. Identify critical components of nursing care for the dialysis patient.
3. Demonstrate knowledge of the relationship between clinical manifestations and underlying psychosocial or pathophysical status of the renal failure patient.
4. Demonstrate ability to teach patients self-care regardless of treatment modality utilizing the principles of adult education.
5. Formulate an individual patient care plan utilizing nursing diagnosis.

**Program Length:** 470 hours / 24 weeks

**Program Schedule:** Modules I-VIII Tuesday and Thursday 6 pm – 9 pm and Saturday 9 am – 4 pm. Three-week break for state examination preparation and to complete the exam. Module IV Externship days and hours are to be determined with the site assigned to.

### ADMISSION PROCEDURES

Admissions procedures include meeting with an admissions representative to review goals, school policies and procedures, the School Performance Fact Sheet, catalog, and graduation requirements. Each prospective student must:



- Provide a high school diploma or equivalent or license.
- Complete the application.
- Interview and tour the facility with a staff member.
- Evidence of physical examination signed by a physician, which indicates you are in good health, have no contagious diseases, and have no physical restrictions, and provide COVID vaccination documentation.
- Provide a lab report for Hepatitis B and TB test or chest x-ray. Prospective students will not be accepted into the program if health report(s) indicate:
  - a. A negative blood test for Hepatitis B surface antigen test.
  - b. A positive blood test for the Hepatitis B surface antibody test; and/or
  - c. A positive tuberculin (T.B.) test or Chest x-ray report within the last six (6) months.
- Provide documentation of a minimum score of 80 on the TOEFL iBT examination if the student is not proficient in English.

Prospective students will be notified in person, by telephone or by mail of the decision to accept or deny admission within ten (10) days after the admissions procedure has been completed.

Upon acceptance into the program, students must:

- Initial and sign the School Performance Fact Sheet.
- Complete an enrollment agreement.
- Pay the registration fee and any other required fees and tuition.
- Pay for malpractice insurance.
- Make payment arrangements; and
- Submit a copy of a valid CPR certification. If CPR certification is needed Millennia Education Institute will provide the training at no cost if accepted into the program and payment of the registration fee.

\$3,500.00 is due at the time of signing the enrollment agreement for program fees and 50% of tuition. The final 50% of tuition is due the first day of the 5<sup>th</sup> month from the program start date. Example: June 4<sup>th</sup> start date the final tuition payment is due on October 4<sup>th</sup>.

Payment arrangements may be considered. A request for a payment arrangement can be discussed with management. At the student's option, Millennia Education Institute will accept payment in full for tuition and fees after the student has been accepted and enrolled and the date of the first class session is disclosed on the enrollment agreement.
